History

National RV Training Academy, LLC is approved by the Texas Veteran Commission under the provision of Title 38, U.S. Code for VA educational benefits to train veteran and other eligible persons for approved programs and courses required for those programs.

National Recreational Vehicle Inspectors Association

The National Recreational Vehicle Inspectors Association (NRVIA) is the certifying body and professional membership organization providing credentials for professional recreational vehicle inspectors across North America. NRVIA's mission is to provide credibility through the testing and awarding of credentials to qualified inspectors. The NRVIA Certified RV Inspector is one of the most highly sought-after certifications in the RV inspection industry.

• Recreational Vehicle (RV) Inspector Program

Certification is designed to assist the RV industry and the public in identifying those professionals who have demonstrated the knowledge and ability to satisfy established standards in RV diagnostic and assessment procedures. Eligible candidates must complete one comprehensive exam consisting of 105 multiple choice questions. The candidate has 95 minutes to complete the test. The passing score for the exam is 70% or 74/105 correct answers. In addition, an onsite practical RV inspection is required demonstrating the candidate's knowledge and ability to satisfy established standards in RV inspections. The practical is pass or fail.

Recreational Vehicle Technicians Association of America

The National Recreational Vehicle Technician Association (RVTAA) is the certifying body and professional membership organization providing credentials for professional recreational vehicle technicians across North America. The RVTAA certifications are designed to assist the RV industry and the public in identifying those professionals who have demonstrated the knowledge and ability to satisfy established standards in RV diagnostic and repair procedures.

• Recreational Vehicle (RV) Service Technician

The registered technician certification exam establishes that the technician is proficient in core knowledge areas such as propane, basic electrical, plumbing, fire & life safety, weight knowledge, and other technical skills as outlined in the RV Service Training Council (RVST Council) Standard/DACUM. This is the first step in becoming a Certified RV Service Technician. Once a technician has achieved Registered technician status, they are eligible to move forward and become a Certified Technician. The candidate has 95 minutes to complete the multiple-choice certification exam. The passing score for the Registered Technician certification exam is 76%.

NOTE: Those currently certified or those with an expired certification are exempt from the Registered Technician certification exam. All other applicants are required to take the Registered certification exam as the first step of the certification process.

• Advanced Recreational Vehicle (RV) Service Technician

Once a technician has achieved the RV Service Technician status, they are eligible to take the Certified RV Service Technician certification exam. The Certified RV Service

Technician exam is the second level in advancing in the RV service technician's career. The certification exam is a comprehensive assessment designed to evaluate both general and specific knowledge as outlined in the RV Service Training Council (RVST Council) Standard/DACUM. The candidate has three hours (180 minutes) in which to complete the multiple-choice certification exam. The passing score for the certification exam is 76%.

• Master Recreational Vehicle (RV) Service Technician

Once a technician has achieved the Advanced RV Service Technician status, they are eligible to take the Master Certified RV Service Technician certification exam after successful completion of three years of documented Certified RV Service Technician work experience. The master certification exam is a comprehensive assessment of advanced knowledge as outlined in the RV Service Training Council (RVST Council) Standard/DACUM. The candidate has three hours (180 minutes) in which to complete the multiple-choice certification exam. The passing score for the master certification exam is 76%.

Facilities and Equipment

The 20,000-square-foot Big Red Schoolhouse & Community Center was constructed in 2017 for the dual purpose of teaching people how to maintain, repair and inspect RVs, as well as to provide a space for members of the surrounding community to hold events. With climate-controlled RV bays big enough to park multiple RVs in, the NRVTA has the room for all the equipment and tools that students need to get the hands-on training required to learn the systems on today's RVs. The three large classrooms feature state-of-the-art equipment including projectors and video cameras connected to big screen televisions to ensure you don't miss a thing during class. Even with all the space inside, we required outside storage for all the RV equipment, appliances, and parts we keep on hand for students to take apart and learn with.

The Big Red Schoolhouse & Community Center, home of the NRVTA, is located on the grounds of the Texan RV Park and Campus in Athens, Texas. The park contains:

- 99 RV sites
- Three small lakes that are well stocked with fish
- Six rental cabins
- Five tiny home rentals

The RV park is situated on 37.4 lush, green acres in beautiful East Texas 66 miles Southeast of downtown Dallas, Texas. The Texan RV Park provides a clean, comfortable, convenient, and relaxing place for our students to stay during the weeks of their classes.

Methods of Payment

The National RV Training Academy, LLC accepts cashier checks, bank checks, cash and all major credit / debit cards. Third-party financing is also available and additional information about this option can be found by contacting a student advisor. Third-party financing is not federal financial aid and does not follow federal guidelines on student loans. The loan is a personal consumer loan and is required to be repaid.

Tuition and Fees Due:

Registration date over 30 days to first day of class - 25% of tuition, booklet and supply fee, exam fee, entrance exam fee and lodging costs, plus \$100 Registration Processing fee due at the time of registration. The remaining balance is due 30 days before first day of class.

30 days or less before first day of class – Full payment is due.

Daily Class Schedule

Students will attend class Monday through Friday from 8:00 AM to 5:00 PM for the National RV Training Academy, LLC program classes. A ten-minute break will be taken for the last ten minutes of each hour of instruction, lunch will be from 12:00 PM to 1:00 PM daily.

The NRVIA and RVTAA credentialing Exam Review classes will be held on Saturday from 8:00 AM to 5:00 PM. A ten-minute break will be taken for the last ten minutes of each hour of instructional review. Lunch will be from 12:00 PM to 1:00 PM.

Course Time Hours

The course time hour is at least 50 minutes of instruction/lab during the 60-minute period.

Office Hours

The National RV Training Academy, LLC office hours are generally from 8:00 AM to 5:00 PM Central Time zone, Monday through Friday. When classes are not in session, the offices will be closed for lunch from 11:45 AM to 1:00 PM. Exam Reviews are scheduled on Saturdays from 8:00 AM to 5:00 PM on select weekends for review and certification testing.

Enrollment Periods

National RV Training Academy, LLC has year round open enrollment. The deadline to enroll into a program is no less than four calendar weeks prior to the first day of class. If a student

wishes to enroll into a class with less than four calendar weeks prior to the first day of class, the school director will allow the student to enroll based upon availability of the requested class and/or program.

Admission / Enrollment Policies / Requirements

All individuals applying for National RV Training Academy, LLC courses are required to:

- Interview with a Student Advisor.
- Present proof to be at least 18 years of age (applicants under the age of 18 require proof of secondary education) through a copy of drivers license or passport.
- Present proof of secondary education (high school diploma, GED certificate or home schooled high school diploma), proof of post-secondary education of at least one full-time academic semester at an accredited post-secondary school, or successful completion of the entrance exam*, or DD214 for military students.
- Take a live or virtual tour of the school.
- Review and sign the required enrollment agreement within 3 business days of receipt.
- Payment in full of tuition, fees, booklets and supplies or 25% deposit of tuition, booklets, supplies, and optional fees (entrance exam, lodging) and 100% of the registration fee (\$100) within 3 business days of signed enrollment agreement.

Note: If student enrolls 30 days or less from the start of class <u>full payment is required at</u> the time of enrollment.

Additional Requirements for Students using Financing or Third-Party Payors

- Apply with the financer or third-party payor to determine eligibility for funding approval.
- If financing, provide all required documentation to financer and sign commitment letter.
- If third-party payor, sign release authorization for NRVTA to communicate with third-party regarding the student's enrollment.

Additional Requirements for Students using Title 38, U.S. Code for VA Educational Benefits

- Provide a Certificate of Eligibility letter from the VA dated no earlier than 90-days prior to the class start date. COE letters may be emailed to admissions@nrvta.com.
 This step must be completed prior to receiving an enrollment agreement from NRVTA.
- Submit all transcripts for both military and post-secondary education completed. Transcripts will be reviewed for possible credit of past related training. This step must be completed prior to receiving an enrollment agreement from NRVTA. This is not necessary for dependents using veteran benefits.

Approved Entrance Exam Options

*Recommended Exam: The National RV Training Academy, LLC offers students the option of taking a 40-minute online entrance exam. This entrance exam option is administered by a third-party company, Wonderlic, and requires the student to complete the entrance exam online using a laptop or desktop computer. This entrance exam is not mobile friendly and

cannot be completed using a phone or tablet/pad. The entrance exam is comprised of two sessions: Verbal Skills and Math. Each session is 20 minutes in length and scores are immediately sent to NRVTA Admissions upon completion. Students must score a minimum of 265 out of a possible 500 on each session to pass the exam for any program offered by the National RV Training Academy, LLC.

The entrance exam fee is \$25.00 for the first attempt and \$20.00 for the second attempt. The entrance exam fees will be added to the student invoice along with the course tuition, books, supplies and any other administrative fees and must be paid in full 30 days prior to starting class. If the student decides to cancel, drop, withdraw, or reschedule, the entrance exam fees are non-refundable. Entrance exam scores are kept on file and students will not need to retake the entrance exam for future enrollments.

Students have two attempts to pass each section of the exam. If the student is unsuccessful in passing the exam after two attempts, is unable to provide other approved testing scores, and is unable to provide proof of secondary or post-secondary education, the student may not enroll into classes at the National RV Training Academy, LLC.

We also will accept scores from other nationally recognized entrance exams such as the ACT, SAT and CLT. Please visit our website to learn more about each exam. Some require in-person testing (which must be scheduled) and some offer an online proctored exam from the comfort of your home or office.

Credit for Previous Training, Education, and Experience

An enrolling student may be granted credit for prior education, training, or experience.

To apply for consideration of credit, a written request with documentation of the education/training/experience must be submitted to the managing director or his/her representative no later than the time of enrollment.

The student may be required to pass a qualification exam with a grade of at least 70 to receive credit. If the credit is granted, the student will not be required to attend classes for that subject and will not be charged tuition or fees for books and supplies for that course.

Discounts

The National RV Training Academy, LLC only offers two possible discounts for course tuition for RVTF 200 RV Fundamentals or INSP 200 RV Fundamentals. Discounts may not be applied to any other courses or programs offered by the National RV Training Academy, LLC. The two discount options are listed below:

- 1. Military Discount: 10% on course tuition only; books, supplies and any administrative fees will still apply in full. Proof of active or retired military status must be submitted with enrollment requirements. This discount may be used only once.
- 2. \$300 Discount from RV Tech Course Home Study Program: \$300 discount is applied on course tuition only; books, supplies and any administrative fees will still apply in full.

Proof of RV Tech Course Home Study Program purchase must be submitted with enrollment requirements and name on order must match student enrollment paperwork. This discount may be used only once and is only eligible for purchases made prior to February 2022. Purchasers of the RV Tech Course PRO version are also eligible for this discount.

Certification Testing Fees

The RVTAA Certification Exam Fees and NRVIA Certification Exam Fees are collected by NRVTA and paid to the respective association upon certification. The fee covers both the exam fee as well as the first year of membership into the respective association. Fees are kept on account with NRVTA until certification is complete and then transferred on the student's behalf to the respective association. If the student were to cancel, drop, withdraw, or not complete the exam, the fee would be returned to the student as a refund. Once certification has taken place from the association, the fee is no longer refundable to the student. These exam fees are in addition to the charges for tuition, books and supplies and any administrative fees paid for classes. The exact fee charged and collected is found within the program costs section of this catalog.

Lodging Option

The NRVTA is housed within the Big Red School House, a facility which is located on the property of the Texan RV Park (TRVP). TRVP is a third-party campground and offers students a multitude of lodging options to stay while attending classes at the NRVTA. Students who are using a third-party payor may choose to include their lodging with their enrollment costs to cover their lodging fees in addition to their education expenses. NRVTA will confirm the lodging needs with the student, book the reservation with TRVP and pay the lodging fees on behalf of the student to TRVP. Upgrades, changes, add-ons, etc. will be the responsibility of the student to pay directly to TRVP. The possible lodging fees are:

Cabins and Tiny Homes include tax, no tax added to TH/CB if stay 31 days or more. All prices are based on a 1-week stay (Sunday-Sunday), 7 nights.

Cancellation Policy

A full refund will be made to any student who cancels the enrollment contract within 72 hours (until midnight of the third day excluding Saturdays, Sundays and legal holidays) after the enrollment contract is signed. Cancellations processed after this 72-hour period following the

signed contract, but before the first day of class, will allow a full refund to the student minus the \$100 registration fee. If the student decides to enroll in a future class, the \$100 registration fee will be charged on the new enrollment.

A full refund will also be made to any student who cancels enrollment within the student's first three scheduled class days, except that the school may retain not more than \$100 in any administrative fees charged, as well as items of extra expense that are necessary for the portion of the program attended and stated separately on the enrollment agreement.

A class must have a minimum of 10 enrolled students for the class to make. The school director may cancel the class and notify the enrolled students no less than 30 days in advance of the class start date. If the class is cancelled, the student will receive a refund for the class tuition, books, and supply fees.

Refund Policy

- 1. Refund computations will be based on scheduled course time of class attendance through the last date of attendance. Leaves of absence, suspensions and school holidays will not be counted as part of the scheduled class attendance.
- 2. The effective date of termination for refund purposes will be the earliest of the following:
 - (a) The last day of attendance, if the student is terminated by the school;
 - (b) The date of receipt of written notice from the student; or
 - (c) Ten school days following the last date of attendance.
- 3. If tuition and fees are collected in advance of entrance, and if after expiration of the 72-hour cancellation privilege the student does not enter school, not more than \$100 in any administrative fees charged shall be retained by the school for the entire residence program or synchronous distance education course.
- 4. If a student enters a residence or synchronous distance education program and withdraws or is otherwise terminated after the cancellation period, the school or college may retain not more than \$100 in any administrative fees charged for the entire program. The minimum refund of the remaining tuition and fees will be the pro rata portion of tuition, fees, and other charges that the number of hours remaining in the portion of the course or program for which the student has been charged after the effective date of termination bears to the total number of hours in the portion of the course or program for which the student has been charged, except that a student may not collect a refund if the student has completed 75 percent or more of the total number of hours in the portion of the program for which the student has been charged on the effective date of termination.
- 5. Refunds for items of extra expense to the student, such as books, tools, or other supplies are to be handled separately from refund of tuition and other academic fees. The student will not be required to purchase instructional supplies, books, and tools until such time as these materials are required. Once these materials are purchased, no refund will be made. For full refunds, the school can withhold costs for these types of items from the refund if they were necessary for the

portion of the program attended and separately stated in the enrollment agreement. Any such items not required for the portion of the program attended must be included in the refund.

6. A student who withdraws for a reason unrelated to the student's academic status after the 75 percent completion mark and requests a grade at the time of withdrawal shall be given a grade of "incomplete" and permitted to re-enroll in the course or program during the 12-month period following the date the student withdrew without payment of additional tuition for that portion of the course or program.

- 7. A full refund of all tuition and fees is due and refundable in each of the following cases:
 - (a) An enrollee is not accepted by the school;
 - (b) If the course of instruction is discontinued by the school and this prevents the student from completing the course; or
 - (c) If the student's enrollment was procured because of any misrepresentation in advertising, promotional materials of the school, or representations by the owner or representatives of the school.
- A full or partial refund may also be due in other circumstances of program deficiencies or violations of requirements for career schools and colleges.
- 8. Refund Policy for Students Called To Active Military Service.

A student of the school or college who withdraws from the school or college as a result of the student being called to active duty in a military service of the United States or the Texas National Guard may elect one of the following options for each program in which the student is enrolled:

- (a) If tuition and fees are collected in advance of the withdrawal, a pro rata refund of any tuition, fees, or other charges paid by the student for the program and a cancellation of any unpaid tuition, fees, or other charges owed by the student for the portion of the program the student does not complete following withdrawal.
- (b) A grade of incomplete with the designation "withdrawn-military" for the courses in the program, other than courses for which the student has previously received a grade on the student's transcript, and the right to re-enroll in the program, or a substantially equivalent program if that program is no longer available, not later than the first anniversary of the date the student is discharged from active military duty without payment of additional tuition, fees, or other charges for the program other than any previously unpaid balance of the original tuition, fees, and charges for books for the program; or
- (c) The assignment of an appropriate final grade or credit for the courses in the program, but only if the instructor or instructors of the program determine that the student has:
 - (1) satisfactorily completed at least 90 percent of the required coursework for the program; and
 - (2) demonstrated sufficient mastery of the program material to receive credit for completing the program.
- 9. The payment of refunds will be totally completed such that the refund instrument has been negotiated or credited into the proper account(s) within 60 days after the effective date of termination. Refunds will be processed by check and mailed to the student at the address on the enrollment agreement.

Satisfactory Progress

A cumulative grade average of at least 70% is required for a student to pass the course. Progress will be evaluated through daily work and the final exam at the end of the course. Daily work is issued through hands-on labs, quizzes and counts for 20% of the cumulative grade average. The final exam given on the last day of class counts for 80% of the cumulative grade average.

Academic Probation, Incompletes, and Withdrawals

A student who is not making satisfactory progress as defined above at the completion of a subject class will be placed on academic probation for the next subject class. If a student on academic probation achieves satisfactory progress for the subsequent subject class, but does not achieve the required grades to meet overall satisfactory progress for the course, the student may be continued on academic probation for one more subject class. If a student on academic probation fails to achieve satisfactory progress for the first probationary subject class, the student's enrollment will be terminated. The enrollment of a student who fails to achieve overall satisfactory progress for the program at the end of two successive subject classes will be terminated.

When a student is placed on academic probation, the school will counsel the student prior to the student returning to class. The date, action taken, and terms of probation will be clearly indicated in the student's permanent file. A student whose enrollment was terminated for unsatisfactory progress may reenroll in a subsequent term in the next 12 calendar months. Such reenrollment does not circumvent the approved refund policy. The school will place a student who returns after his/her enrollment was terminated for unsatisfactory progress on academic probation for the next subject class of the term. The school will advise the student of this action and it will be documented in the student's file. If the student does not demonstrate satisfactory progress at the end of this probationary period, that student's enrollment will be terminated.

*Incomplete: An "I" for Incomplete is assigned when all the work of a subject class cannot be completed due to circumstances beyond the control of the student. The student may complete the work by the end of the term, or the student can notify the school registrar for readmission for one opportunity to complete the work in a subsequent term beginning no later than 12 calendar months after the end of the term in which the student was assigned the "I". There will be no additional registration or tuition fees charged for students who exercise this option; however, there may be additional fees for booklets, supplies.

**Withdrawal: Under Texas Education Code §132.061(f), a student who is obligated for the full tuition and is withdrawing for an appropriate reason unrelated to the student's academic status may request a grade of "I" for incomplete.

A "W" for Withdrawal indicates that the student officially withdrew or was administratively withdrawn from the subject class. A student with a grade of "W" cannot complete the course of study and will be issued a refund in accordance with the refund policy below.

Remedial Work, Repeat Courses and Audit Requests

The National RV Training Academy, LLC does not offer remedial work. A student who has completed the course of study but does not meet course completion requirements can contact the registrar for one opportunity to repeat subject classes with unsatisfactory grades in a subsequent term beginning no later than 12 calendar months after the end of the term in which the student was originally enrolled. There will be no additional registration fees charged for students who exercise this option; however, there may be additional fees for tuition, booklets and supplies.

When a student requests to repeat a completed and passed course, discounted tuition, booklets and supply fees will be required. Repeat requests are submitted to the school director for approval only in courses with availability. The higher grade for the repeated subject class will be considered in the determination of the student's grade average for the course of study.

Repeated Courses are charged at a 50% discount for tuition, booklets and supply fees. The full \$100 registration fee will be charged for repeated courses.

Audit requests are handled as a Repeat Course.

Attendance

Students are expected to attend all lectures, labs, and the externship and to be punctual in attending classes. Instructors will maintain the record of attendance for all students three times a day for day classes. A tardy is defined as arriving in the classroom after the designated time for the beginning of the class or for the continuation of class after breaks. Five tardies to class will be counted as one absence. All tests missed due to the absence of a student must be taken on the first day of attendance after the student's absence.

MAKE-UP WORK

No more than 5% of the total course time hours for a program may be made up. Make-up work shall:

- (1) Be supervised by an instructor approved for the class being made up;
- (2) Require the student to demonstrate substantially the same level of knowledge or competence expected of a student who attended the scheduled class session;
- (3) Be completed within two weeks of the end of the grading period during which the absence occurred;
- (4) Be documented by the school as being completed, recording the date, time, duration of the make-up session, and the name of the supervising instructor; and

(5) Be signed and dated by the student to acknowledge the make-up session.

A student who misses more than 10% of class hours will be placed on attendance probation with conditions stipulated by the school director. Enrollment in the program will be *terminated for a student who is absent for more than 20% (41 hours) of the class hours of the program. A student whose enrollment was terminated due to unsatisfactory attendance may reenroll on attendance probation in a subsequent term in the next 12 calendar months. Such reenrollment does not circumvent the approved refund policy. If the reenrolled student on attendance probation is absent for more than 20% of the class hours the student's enrollment in the program will be *terminated, and the student will not be readmitted to the program.

*National RV Training Academy, LLC will not terminate the enrollment of a student for lack of attendance at a point at which a refund would not be due.

Leave of Absence

The school director may grant a leave of absence after determining that good cause is shown. School attendance records will clearly define the dates of the student's leave of absence. A written statement of the reason(s) leave of absence was granted, signed by both the student and the school director indicating approval, will be placed in the student's permanent file.

Course Graduation Requirements

A Certificate of Completion will be awarded to each student who completes all the subjects of the course of study with a minimum passing grade of 70%. A student who has completed the course of study but does not meet course completion requirements can contact the registrar for one opportunity to repeat subject classes with unsatisfactory grades in a subsequent term beginning no later than 12 calendar months after the end of the term in which the student was originally enrolled. There will be no additional registration fees charged for students who exercise this option; however, there may be additional fees for tuition, booklets and supplies.

Readmission

Timelines and conditions for reenrollment are described under the following titles of this catalog: Attendance Policy, Grading Policy/Incomplete, Course Completion Requirements, Academic Probation, and Student Conduct Expectations. Students wishing to be readmitted and enrolled should contact the school at (903) 386-0444.

If the student enrolls to repeat a subject that is no longer offered, the school director will select an appropriate substitute subject for the student to meet that part of the program requirement.

Student Conduct Expectations

- 12. Possessing a firearm or other deadly or dangerous weapons such as knives, knuckles, clubs, baseball bats, and hammers while on the property of the school or in any part of the school building
- 13. Sexual harassment in any form by students or any member of the administration, faculty, or staff is prohibited. Student Complaints & Grievances

Complaints are defined as any student concern regarding the school programs, services, or staff. A student who has a concern about a school-related issue is encouraged to schedule a conference with the school director to find resolution. If an issue is not resolved to a student's satisfaction through the conference, the student can file a formal complaint in writing with the school director who will formally investigate the complaint, take appropriate action, and provide a written response to the student by the 10th business day after the day the formal written complaint is received by member of the school faculty or staff.

Note: a conference with the director is not required before a student files a formal written complaint.
